Commitment Information

- Mandatory Team Rehearsals ~ minimum 2 per week (Thursdays: 7 pm – 9 pm and Sundays: 2 pm – 5 pm)

RUSH RUSHETTES WAIVER AND RELEASE OF LIABILITY AGREEMENT

The undersigned agrees and understands as follows:

1. The undersigned desires to participate in the Rapid City Rush Rushettes Dance Team tryouts and/or seminar/dance clinic (the **“Tryouts”**) in Rapid City and/or Pennington County, South Dakota, sponsored by Rapid City Rush Pro Hockey, LLC (the **“Rush”**). The undersigned acknowledges that the undersigned’s participation in the Tryouts is a voluntary decision. The undersigned understands there are inherent risks of personal injury and possible death associated with the undersigned’s participation in the Tryouts. Risks include but are not limited to, collisions with other individuals, broken and sprained bones, sprained and torn muscles, eye loss and death. The undersigned acknowledges and agrees that the Rush owe the undersigned no duty of care with respect to the Tryouts. The undersigned further warrants that the undersigned does not have any health or physical impairments that might be aggravated by participating in the Tryouts.
2. The undersigned accepts full responsibility for any injury, damage or death resulting from the undersigned’s participation in the Tryouts, and hereby releases the Rush, its officers, directors, members, managers, employees, agents and the assigned and successors of the Rush, from any and all claims, demands, damages, actions, or suits of any kind, including the negligent acts or omissions of the Rush or its agents, which may arise in connection with the undersigned’s participation in the Tryouts, or for any other reason.
3. The undersigned acknowledges that the undersigned is either 18 years of age or older and by executing this Agreement the undersigned agrees to all terms and provisions hereof. If the undersigned is under 18 years of age, a signed Parental Consent Form must accompany this Agreement.
4. The undersigned agrees to indemnify, defend, and hold the Rush harmless from any attorney’s fees, expenses, or costs in the event of any cause of action, suit, demand, or claim of any kind which may arise out of the undersigned’s participation in the Tryouts.
5. The undersigned grants permission to Rapid City Rush Pro Hockey, LLC and other performers and their agents to utilize the undersigned’s image and/or likeness incidental to any live or recorded video or other display, transmission or reproduction in whole or in part of the Tryout.
6. If the undersigned is selected as a Rapid City Rush Rushettes after participating in the Tryouts, this Agreement shall remain in effect for the entire Rushettes 2009-10 season and apply to the undersigned participation as a dancer/cheerleader for the Rapid City Rush.
